## Preventing Extremism and Radicalisation Policy

Policy written: September 2022

Due for review: September 2024

From 1 July 2015, all schools are subject to a duty under section 26 of the Counter-Terrorism and Security Act 2015, in the exercise of their functions, to have “due regard to the need to prevent people from being drawn into terrorism”. This duty is known as the Prevent Duty for Schools.

This means we have a responsibility to protect children from extremist and violent views the same way we protect them from any other harm.

The statutory guidance refers to the importance of Prevent awareness training to equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas. The Home Office has developed a core training product for this purpose – Prevent Awareness online Training. Several members of our teaching and non-teaching staff have completed this training, understand what Prevent is about and how to deal with any issues they may see inside or outside school.

### What does this look like at Pontesbury CE Primary School?

At Pontesbury CE Primary School, we build pupils’ resilience to radicalisation by promoting British values and enabling our pupils to challenge extremist views.

Many of the things we already do in school to help children become positive, happy members of society also contribute to the Prevent strategy. These include:

- Having a strong Vision and Aims which permeates our school.
- Exploring other cultures and religions and promoting diversity.
- Challenging prejudices and racist comments.
- Developing critical thinking skills and a strong, positive self-identity.
- Promoting the spiritual, moral, social and cultural development of pupils, as well as British values such as democracy.

We will also protect children from the risk of radicalisation, for example by using filters on the internet to make sure they can’t access extremist and terrorist material, or by vetting visitors who come into school to work with pupils.

The school will make sure any discussions are suitable for the age and maturity of the children involved.

### Is extremism really a risk in our area?

Staff working with children are advised to maintain an attitude of ‘it could happen here’ where safeguarding is concerned.

Extremism can take many forms, including political, religious and misogynistic extremism. Some of these may be a bigger threat in our area than others.

We will endeavour to give children the skills to protect them from any extremist views they may encounter, now or later in their lives.
